Wage hike seen in CL

ITY OF SAN FERNANDO — A new minimum wage rate in Central Luzon will take effect on October 17, 2024 after its affirmation by the National Wages and Productivity Commission (NWPC) and publication in a local daily.

Wage Order No. RBIII-25 mandates a Php50 to Php66 increase in the daily minimum wage of workers in private establishments in Central Luzon.

"The Php50 to Php66 increase will be given in two tranches: Php25 to Php41 upon effectivity of the wage order on October 17, 2024, and another Php25 effective April 16, 2025," Regional Tripartite Wages and Productivity Board (RTWPB) Chairperson and Department of Labor and Employment-Central Luzon Regional Director Geraldine Panlilio explained.

Under the first tranche, the new minimum wage in the Provinces of Bataan, Bulacan, Nueva Ecija, Pampanga, Tarlac and Zambales will be Php525 for non-agriculture, Php495 for agriculture, and Php515 for retail/service.

Upon implementation of the second tranche, the minimum wage in the Provinces of Bataan, Bulacan, Nueva Ecija, Pampanga, Tarlac and Zambales will be Php550 for nonagriculture, Php520 for agriculture, and Php540 for retail/service.

On the other hand, the minimum wage in the Province of Aurora, upon effectivity of the first tranche, will be Php475 for non-agriculture, Php460 for agriculture, and Php410 for retail/service.

Upon implementation of the second tranche, the minimum wage in Aurora will be Php500 for nonagriculture, Php485 for agriculture, and Php435 for retail/service. (PIA **REGION 3-PAMPANGA)**

The group assembled at the Capitol Grounds then walked to the Metropolitan Cathedral of San Fernando to hear Mass officiated by Archbishop Emeritus Paciano 'Apung Ceto' Aniceto.

After the Mass, the team proceeded to the COMELEC in the city to file their respective COCs.

Pineda-Cayabyab will formally seek the mayoralty post of the capital city while Lagman will seek reelection as vice-mayor.





Bishop Ambo named Cardinal

Pope Francis has named Catholic Bishops' Conference of the Philippines (CBCP) President and Kalookan Bishop Pablo Virgilio David a new cardinal, along with 20 others from various places around the world.

Pope Francis made the announcement during his weekly Sunday Angelus at the Vatican City on Sunday, October 6, 2024.

The pope said the consistory for the creation of new cardinals will be held on December 8, 2024, just a few days before the opening of the Jubilee Year of 2025.

Upon becoming a cardinal, David will become one of three cardinals in the Philippine Catholic Church. The other two are Cardinal Luis Antonio Tagle and Manila Archbishop Cardinal Jose Advincula.

David, popularly known as Bishop Ambo, was born in Betis, Guagua, Pampanga and was ordained as a priest for the Archdiocese of San Fernando in 1983. He became auxiliary bishop of San Fernando in 2006 before he was appointed bishop of Caloocan.

He is recognized as one of the Philippines' foremost biblical scholars, having earned a Doctorate in Theology from the Catholic University of Louvain in Belgium, and has 41 years of priesthood and 18 years as a bishop experience.

He is known as a staunch critic of the notorious war on illegal drugs championed by former President Rodrigo Duterte that saw many alleged drug-related killings.

Zero-emissions aircraft, hydrogen production eyed

The Bases Conversion and Development Authority (BCDA) has signed a partnership agreement with Australian zero emissions aircraft designer and manufacturer AMSL Aero to explore a new zero-emissions aircraft industry and provide the catalyst for a hydrogen production industry in the Philippines.

The partnership between



BCDA and AMSL Aero involves collaboration and knowledge sharing to develop an ecosystem for low-cost zero emissions aircraft and hydrogen energy that has the potential to connect the archipelago of the Philippines by passenger and freight carriage air bridges, coupled with strategically located hydrogen production plants for clean energy production.

This will lead to the preparation of a feasibility study, which may include technical and commercial study of the project with potential developments within the BCDA's properties.

AMSL Aero is an Australianbased sustainable development aerospace technology company that produces a world-leading, long-range hydrogen-electric Vertical Take Off and Landing

(VTOL) aircraft, the Vertila.

The Vertila is a nextgeneration aircraft that takes off
like a helicopter and flies fast
and smoothly like a fixed-wing
aeroplane at a very low cost
per hour. The aircraft will be a

of up to 1,000 kilometers and

Displaced Balubad residents OK relocation in Magalang

ANGELES CITY — About 2,000 families from Sitio Balubad, Barangay Anunas here have agreed to be relocated to San Ildefonso, Magalang town where they will each receive 50-squaremeter lots under the city government's socialized housing project.

City Councilor Atty. Arvin "Pogs" Suller, officer-in-charge of the Angeles City Human Settlements and Urban Development Office (ACHSUD), facilitated a meeting with the affected families on October 4, 2024 on behalf of Mayor Carmelo "Pogi" Lazatin Jr. to discuss their relocation options.

"Upon Mayor Lazatin's instructions, we presented the homeowners-beneficiaries with three choices — expropriation proceedings or relocation to Barangay Mining or Magalang town. After a majority vote, they chose the Magalang property for their new community," Suller shared.

Suller said the initial plan was to allocate 45 square meters per beneficiary but the mayor expanded it to 50 square meters at the residents' request.

"Sa katunayan po, the original plan was 45 square meters per household. But it was adjusted to 50 square meters upon the request of our beneficiaries to Mayor Lazatin," Suller explained.

The homeowners' Acting President Mary Joy Paragas expressed the residents' approval of the relocation plan saying: "We are grateful to Mayor Lazatin for considering our request and providing us with a better option. Buo po ang aming suporta para sa proyektong relokasyon na ito na magsisilbing pong bagong panimula para sa aming lahat".

The ACHSUD has already

The ACHSUD has already started mapping and tagging the tenants to ensure the smooth and safe relocation of the displaced families.

The relocation effort follows

the passage of resolutions by the Angeles City Council, led by Vice-Mayor Vicky Vega-Cabigting, on October 17, 2023 which authorized Lazatin to initiate expropriation proceedings or purchase parcels of land at Sitio Balubad, Barangay Anunas, for the city's socialized housing project.

"Gaya po ng pangako ko, walang bibitaw, hindi ako bibitaw, hindi ko kayo iiwan," Lazatin assured to the beneficiaries.

The beneficiaries were displaced after private real estate firm Clarkhills Properties Corp. took over the property they were living in which led to resistance and several violent and bloody clashes between the residents and the company's demolition crew.

At least seven persons were injured in one of the more violent clashes involving armed security guards and local policemen. (ANGELES CIO)

PWS Pampanga's facility in Porac is designed to handle up to 5,000 tons of solid waste daily, employing advanced technology to maximize resource recovery and to reduce landfilled waste by 20 percent or less.

"Yung waste na nare-recover upon segregation, may tamang mapupuntahan, like ginagawa nilang RDF or refuse derived fuels. So, yung basura, mapapakinabangan pa," Navarro said.

Threat of marine litter to human health, food security, economy and environment

Some 352,479 kilograms of trash and debris, ranging from plastics to other waste materials, were collected in 250 coastal sites across the country during the International Coastal Cleanup (ICC) last September 21,

ICC is the world's largest volunteer effort for the ocean's health and is being conducted every third Saturday of September of each year to raise awareness about the impact of plastic pollution on marine life and ecosystems.

ICC engages people to remove marine litter or trash from beaches, rivers, lakes and waterways and to identify and record trash/debris items collected in an Ocean Trash Data form.

The ICC was part of the activities of this year's 29th National Seafarers' Day (NSD) and 25th National Maritime Week (NMW) with the theme "Marinong Filipino: Ligtas na Paglalayag" spearheaded by Stella Maris Philippines and the Philippine Coast Guard.

Marine litter is any persistent, manufactured or processed solid material discarded directly or indirectly into the sea, rivers or on beaches.

Marine litter poses threats to human health, food security, economy and environment, including degradation of marine and coastal habitats, ecosystems and biodiversity.

A major source of pollution are single-use disposable plastics which come in various forms such as straws, sachet packs, bags, cutleries, cups, and plastic bottles which are meant to be used only once, before being thrown away.

If there are no drastic interventions, by 2050 there will be more plastics than fish in the ocean.

Plastic bags take 10-20 years to decompose while plastic bottles take 450 years.

These items tend to shrink into smaller pieces (called microplastics), which never achieve full decomposition and return to the food cycle through ingestion by fish and other animals as "false food", causing digestive failure, suffocation, starvation, drowning and eventually death. Some animals become fatalities due to entanglement.

The Philippines, which disposes 2.7 million tons of plastics per year, is considered the third largest global contributor to the 8 million tons of

plastics that are estimated to flood our oceans each year.

More than 163 million plastic sachet packets, as well as 48 million shopping bags and 45 million thin-film bags are used and disposed of daily in the

The more visible manifestations of the problem due single-use plastics include the clogging up of waterways, drainage systems, and therefore contributing to floods.

Marine litter, specifically plastic pollution, was discussed by Von Hernandez of the Break Free From Plastic Movement during one of my Amigos Marino online show as part of 2021 Earth Day celebration.

Hernandez echoed the call of environmental groups for the passage of a comprehensive Single-Use Plastic Ban as an essential policy tool to stop plastic pollution by shifting corporate dependence on throwaway packaging models to more sustainable reuse and refill systems.

Single-use plastic is not a cleanup problem but a pollution problem, Hernandez stressed, adding that the only way to prevent it is to stop its production and avoid using them in the

first place.

This means looking at plastic at the different stages of the lifecycle, and not just treating it as a waste management or consumer responsibility issue, which is what the plastic industry wants.

including Marine pollution, handling of garbage from ships, is addressed by Annex V regulations of the International Convention for the Prevention of Pollution from Ships (MARPOL), as first drafted in 1973 and amended in 1978.

MARPOL seeks to ensure that the marine environment is preserved by the elimination of pollution by all harmful substance which can be discharged from the ship.

Annex V, which came into force on 31 December 1988, expressly prohibits all ships from discharging garbage, which includes all kinds of food, domestic and operational waste, all plastics, cargo residues, incinerator ashes, cooking oil, fishing gear, and animal carcasses generated during the normal operation of the ship and liable to be disposed of continuously or periodically.

The most important feature of the

Annex is the complete ban imposed on the disposal into the sea of all forms of plastics, including but not limited to, synthetic ropes, synthetic fishing nets, plastic garbage bags and incinerator ashes from plastic products which may contain toxic or heavy metal residues.

It specifies the distances from land in which materials may be disposed of and subdivides different types of garbage and marine debris.

The requirements are much stricter in a number of "special areas".

There must be a garbage management plan which is a complete guideline that comprises of a written procedure for collecting, storing, processing, and disposing of garbage generated onboard ship.

Vessels are obliged to deposit plastic waste at reception facilities ashore as port state signatories are required to provide adequate and appropriate reception facilities.

Switches flicked in Pampanga, Tarlac politics

Switches abounded in the political scene in the provinces of Pampanga and Tarlac as local leaders, related at that, have traded places during the filing of Certificates of Candidacy (COCs) for the upcoming May 12, 2025 National and Local Mid-Term

In the Province of Pampanga, Governor Dennis "Delta" Pineda announced at the last minute on October 8, the last day of filing, that he and his mother, Vice-Governor Lilia "Nanay" Pineda, will switch places with the elder Pineda now running for the gubernatorial seat and the son sliding to vice-governor.

Despite The Big Switch or Trading of Posts, the governor assured that he and the vice-governor will continue providing good service to everyone.

The move is a comeback for Nanay

Pineda. She completed three terms as governor from 2010 to 2019 before passing over the helm to her son. Delta, who will be completing his second term next year.

They are up against businessman and former Candaba Mayor Danilo Baylon who will have for his running-mate former Governor Among Ed Panlilio who is making

a comeback. In Tarlac Province, the Yaps also made a switch. Rep. Christian "CY" Yap will now run for governor while former governor and Congressman Victor "VY" Yap will run for Second District Congressman.

Governor Susan Yap, meanwhile, will be seeking the mayoral seat of the provincial

capital Tarlac City.
In Angeles City, Mayor Carmelo "Pogi"
Lazatin Jr. and his brother, Pampanga First District Representative Carmelo "Jon"

Lazatin II, traded places with the mayor now gunning for the Congressional Seat while his brother will fill the gap for city mayor.

Pogi will be challenged for the

Congressional Seat by Mike Pangilinan while Jon and running-mate incumbent Vice-Mayor Vicky Vega-Cabigting will face former PNP Chief Oscar Albayalde and his vice-mayoral candidate former city councilor Amos Rivera who both have a full line-up of incumbent councilors and council hopefuls.

Meanwhile, in Mabalacat City, there was no switch but a father-daughter team as Mayor Crisostomo Garbo officially filed his COC for a third term as mayor with his running-mate, daughter Board Member and former three-term councilor Winwin Garbo.

The filing drew a massive crowd approximately 10,000 supporters, showcasing a strong backing for Garbo and his team which include incumbent councilors Timothy Dee, Doc Cocoy Tiglao, Noel Castro, Rox Peña, Carlo Dizon, Jerry Magsino, along with incumbent Barangay Captains Elmer Mendiola and Elmer Calaguas, and former MCTEG head Ralph

Garbo will be challenged by Vice-Mayor Gerald Aquino, his former running mate in the previous elections, for the top city post.

similar team-up occurred in the Municipality of Porac where incumbent Mayor Jing Capil filed his COC for reelection with his only daughter Ma. Jen Capil as his running-mate.

Incumbent Vice-Mayor Francis "Budoy" Tamayo yielded his post to the younger Capil but assured the people that he would stand by the Capils and serve in whatever capacity. (JOJO C. DUE)

The petition prays for the cancellation of petitioner's Certificate of Live Birth registered in the Local Civil Registrar of Lubao, Pampanga under LCR No. 91-4936, to avoid confusion and double registration.

Clark aviation campus to meet future job demand

CLARK FREEPORT ZONE The Clark International Airport Corp. on Monday announced a new initiative aimed at producing globally-qualified and high-performing personnel that will meet the strong global demand for aviation-industry workers and professionals.

The CIAC said the agency's business ventures team was directed to roll-out plans to build the aviation campus with comprehensive curricula and state-ofthe-art facilities strategically situated near the Clark International Airport inside the government-owned civil aviation complex.

In a 2023 Aviation Talent Forecast by CAE Inc., a Canadian aviation training service provider, it was estimated that within ten years, around 1.3 million civil aviation professionals will be needed, which includes 284,000 new pilots, 402,000 new technicians, and 599,000 new cabin crew staff.

The CIAC's aim is to position Clark as the nation's lead source of globally-qualified and high-performing aviation professionals such as skilled pilots, air traffic controllers, aeronautical engineers, aircraft mechanics, radio specialists, and ground support executives and operators.

The CIAC is following the lead of Transportation Undersecretary Roberto C.O. The CIAC said the Philippines' civil aviation education needs an industry upgrade, starting with reputable and comprehensive pilot training programs, along with skills training in components and assembly manufacturing which will expand into production engineering, procurement and distribution.


The government-owned firm also noted the aviation campus will redefine the aviation landscape

NBI expands clearance services

of Investigation (NBI) has
enhanced public access to its
services by introducing mobile
clearance units and streamlining
online processes in Central

Luzon.
"These efforts aim to make it easier for residents across the region to secure the crucial NBI region to secure the crucial NBI clearance, often required for employment, travel, and other legal purposes," NBI Acting Regional Director Isaac Carpeso Jr. explained during the Kapihan sa Bagong Pilipinas of the Philippine Information Agency (PIA).

(PIA).

Carpeso stressed the importance of NBI clearance and its role in the daily lives of

and its role in the daily lives of Filipinos.

"Aside from our core investigative work, the issuance of an NBI clearance is critical for employment, both locally and abroad, visa applications, and other legal processes," he said.

The NBI's mobile service, dubbed "NBI Clearance on-Wheels", brings clearance application services directly to communities, ensuring greater accessibility for individuals who may not have easy access to regional or district offices, as Carpeso stressed the bureau's ongoing commitment to providing efficient and accessible services.

"The initiative

initiative reflects our focus on making NBI services as convenient as possible for the possible for the public," he pointed out. As of September 15, the NBI-Central Luzon Regional Office

has processed 51,939 applications, 2,680 of which are first-time jobseekers received their NBI

clearance free, under the Republic Act 11261 or the First Jobseekers Assistance Act.

Meanwhile, NBI-Regional Office 3 Clearance Center Chief Ma. Arianne Falcon discussed recent improvements to the clearance application process.

"To ensure convenience and efficiency, we streamlined

and efficiency, we streamined the entire process. Applicants can now register, schedule appointments, and make payments online through various payment channels like e-wallets and online banking," Falcon explained. explained.

explained.
Once registered and payment is made, applicants can visit the nearest NBI Clearance Center on their scheduled appointment date for photo and biometric processing. Falcon added that the entire process for applicants to receive their clearance can take as little as one week.
"We've also introduced an online renewal system for faster service. Renewals can

faster service. Renewals can be processed within a day at our main office in Manila, and door-to-door delivery is available for those outside the National Capital Region, taking about seven to ten working days," she

DOLE-3 boosts CL employment drive

CITY OF SAN FERNANDO The Department of Labor and Employment (DOLE) is actively promoting employment and safeguarding workers' rights in Central Luzon.

Central Luzon.

During the Kapihan sa
Bagong Pilipinas of the Philippine
Information Agency (PIA), DOLE
Assistant Regional Director
Alejandro Inza Cruz emphasized
the agency's efforts to create
meaningful employment, enhance
human resources, and protect
worker welfare, all while maintaining
industrial peace. industrial peace.

"Our aim is to ensure that every Filipino worker enjoys full, decent, and protected employment," Cruz stated, adding that DOLE's team of over 400 staff in the region drives labor initiatives, playing a key role in achieving this vision

Cruz highlighted the success of the agency's year-round job fairs which effectively connect job seekers with employers.

At the Labor Day Job Fair, over 5,432 participants applied for more than 34,000 available vacancies where 290 applicants were hired on

the spot. Similarly, Similarly, the June 12 Independence Day Job Fair attracted 3,644 attendees, resulting in 246 immediate hires.

Altogether, DOLE's job fairs this year have led to over 3,000 onthe-spot hires.

These job fairs are essential in addressing unemployment and providing immediate work opportunities for Filipinos," Cruz

addition to facilitating In employment, DOLE actively ensures labor standards compliance across kev industries. This year, the agency inspected more than 4,000 establishments, focusing on sectors such as manufacturing, construction. agribusiness, and business process

outsourcing.
"These inspections address workplace issues and uphold workers' rights as we are committed to keeping workplaces compliant and protecting the rights of workers,"

Cruz stressed. He also underscored DOLE's flagship livelihood programs, which

tagship livelinood programs, which assist disadvantaged workers.

Through the DOLE Integrated Livelihood Program, nearly 5,000 beneficiaries in Central Luzon received Php65 million in livelihood support this year. Among the recipients were 590 parents of child laborers who received livelihood packages designed to take their packages designed to take their children out of hazardous labor and ensure sustainable incomes.

"Supporting the parents of child laborers is the key to combating child labor and helping families break the cycle of poverty," Cruz explained.

Other beneficiaries included 83 jeepney drivers and operators affected by the public utility vehicle modernization program. DOLE provided Php30,000 worth of in-kind assistance to help them start small businesses, such as goat and hog raising, ice cream selling, and LPG retailing. The agency also extended grocery and rice retailing packages to 44 parolees to 55, reintegration into society.

DOI F's Emergency

The DOLE's Emergency Employment Program also served as a critical source of relief, providing temporary jobs to 175,810 individuals this year and disbursing Php966.96 million in wages.

In collaboration with the Bureau of Jail Management and Penology (BJMP), DOLE facilitated temporary work for 449 Persons Deprived of Liberty (PDLs) through activities such as grass cutting, waste segregation, and vegetable

"These programs not only provide immediate assistance but also restore workers' dignity by enabling them to contribute to

society," Cruz said.
