

Capitol to mediate in Porac quarry row





ITY OF SAN FERNANDO — The **Provincial Government of Pampanga is** moving to mediate a dispute between the Porac LGU and local sand and gravel haulers, after about 40 quarry operators and 850 haulers temporarily halted their operations

The halt in operations was triggered by Porac's new ecological tax scheme, which was increased from ₱100 per truck to ₱100 per 12-cubic-meter load, which has further affected larger trucks such as 16- and SEE 4

BOC Clark seizes ₱807-K kush hidden in 'Labubu' toys

CLARK — The Bureau of Customs (BOC), through the Port of Clark, intercepted 538 grams of high-grade marijuana or "Kush" worth an estimated ₱807,000 after discovering the illegal substance concealed inside stuffed "Labubu"

parcel, declared as "keychains," originated from Hong Kong and was bound for Biñan, Laguna.

Customs Commissioner Ariel F. Nepomuceno commended the alertness of Port of Clark personnel and partner agencies, noting that the successful seizure reflects the agency's strong commitment to blocking illegal drugs at the country's borders. The shipment arrived on November 15, 2025, and was flagged by the BOC's X-ray Inspection Project after suspicious images were detected during scanning.

On November 19, a K-9 sniff test conducted by the Philippine Drug Enforcement Agency

(PDEA) produced positive results for narcotics. A physical examination later uncovered two boxes of "Labubu" keychains, each containing two sealed pouches filled with dried leaves and fruiting tops suspected to be Kush marijuana. Chemical analysis by PDEA confirmed the substance as tetrahydrocannabinol (THC), a dangerous drug under Republic Act No. 9165.

The BOC issued a Warrant of Seizure and Detention for violations of Sections 118(g), 119(d), and 1113 (f), (i), and (l) of the Customs Modernization and Tariff Act, in relation to R.A. 9165. District Collector Jairus S. Reyes lauded the vigilance and profiling skills of frontline officers, emphasizing that the Port of Clark continues to intensify its campaign against drug smuggling in line with President Ferdinand R. Marcos Jr.'s directive to strengthen border security and protect public welfare.

Cong Pogi: Trees before permits

ANGELES CITY - Congressman of traditional indigenous family Carmelo "Pogi" Lazatin, Jr. wants to integrate a Tree Planting Plan (TPP) as an additional requirement for the issuance of building permits through his proposed House Bill No. 6325, filed on November 24, 2025.

To be known as the 'Building Green Act' if passed, HB 6325 mandates the inclusion of a TPP in the application for building permits, in addition to other permit requirements. coverina construction, additions, alterations, and major repairs under Presidential Decree No. 1096 or the National Building Code, with the exemption

dwellings and projects exempted under the Code and its IRR.

ENATOR Imee Marcos shocked the more than 650,000 Iglesia Ni Cristo crowd that gathered at the Quirino Grandstand on November 17 when Manang Imee accused her younger brother President Ferdinand "BongBong" Marcos Jr. of being hooked on drugs.

Imee, who has been a critic of his brother since he broke his ties with Vice President Sara Duterte, pleaded BongBong to seek immediate treatment and

repeatedly urged him to prioritize his health and step down from office. She likewise accused her sister-in-law, First Lady Liza and their children, most especially House of Representatives majority floor leader Sandro, of being drug users.

She said, "I won't be able to bear it if something happens to you, so I'm asking you to come home and rest, for the sake of your health.'

The utterances of Imee was a great shock to all of us... a great shock to the entire world as this is probably the first time in the history of mankind that a sibling of a sitting president did this.

Indeed, what Imee executed was un-Filipino like. You see, we Filipinos do not wash our dirty linens in public... if we have a spat within our family, we keep it among ourselves, we keep silent and we solve our problems

among ourselves.

But Imee seems to be different - her state of mind is out of this world. Imee is aligned with the Sara Duterte and the rest of the Duterte clan - the same Sara Duterte who said on live television that she will exhume the remains of Marcos Sr. at the Libingan ng mga Bayani and scatter it all over the West Philippine Sea. 
fake ng mukha mong retokada."
Sandro for his part said, "To further repeat an accusation against President Bongbong Marcos and the First Lady (and for the first time even myself) that is not only false, but dangerously irresponsible".

Was Imee pressured by the DDS to finally hit, adding belowthe-belt?

ICTIMS of trafficking face profound suffering that may last their lifetime, the incalculable injustice perpetrated by people who make a living out of deceiving unsuspecting victims, taking advantage of their vulnerability. They must be penalized.

Thus declared the Supreme Court, through Senior Associate Justice Marvic Leonen, in the case of People vs. Valencia (G.R. No. 234013, June 16, 2021) that involved minor girls being offered to foreigners for sexual

Human trafficking is a significant violation of fundamental human rights, also dubbed as

"modern-day slavery".

The main law against human trafficking in the Philippines is R.A. 9208 (Anti-Trafficking in Persons Act of 2003), which makes it a crime to traffic in persons for purposes like sexual exploitation, forced labor, or organ removal. Other relevant laws include RA 7610 (protection of children), RA 6955 (anti-mail order bride), and RA 8042 (migrant workers).

The elements of trafficking in persons under RA. No. 9208 based on the act, means and purpose are:

(1) The ACT of "recruitment, transportation, transfer or harboring, or receipt of persons with or without the victim's consent or knowledge, within or across national borders."

(2) The MEANS used which include "threat

or use of force, or other forms of coercion, abduction, fraud, deception, abuse of power or of position, taking advantage of the vulnerability of the person, or, the giving or receiving of payments or benefits to achieve the consent of a person having control over another: and

(3) The PURPOSE of trafficking is exploitation which includes "exploitation or the prostitution of others or other forms of sexual exploitation, forced labor or services, slavery, servitude or the removal or sale of organs.

In People vs Casio (G.R. No. 211465. December 3, 2014), Leonen said that trafficking in persons is a deplorable crime. It is committed even though the person knew about or consented to the act of trafficking.

"Human trafficking indicts the society that tolerates the kind of poverty and its accompanying desperation that compels the victims to endure indignities. It reflects the weaknesses of that society even as it convicts those who deviantly thrive in such hopelessness

"We should continue to strive for the best of our world, where our choices of human intimacies are real choices, and not the last resort taken just to survive. Human intimacies enhance our best and closest relationships. It serves as a foundation for two human beings to face life's joys and challenges while continually growing together with many shared experiences. The quality of our human relationships defines the world that we create also for others.'

"We express the hope that our people and our government unite against everything inhuman. We contribute to a commitment to finally stamp out slavery and human

Leonen added, "There are more victims out there. They, too, deserve to be rescued. They, too, need to be shown that in spite of what their lives have been, there is still much good in our world.'

A 2024 paper by the US Department of State noted that traffickers exploit women and children from rural communities, conflict- and disaster-affected areas, and impoverished urban centers in sex trafficking, forced domestic work, forced begging, and other forms of forced labor in tourist destinations and urban areas around the country.

It added that traffickers exploit men in forced labor in the agricultural, construction, fishing, and maritime industries, sometimes through debt-based coercion.

It added that "some corrupt officials allegedly accept bribes to facilitate migration outside of regular channels for overseas workers, operate sex trafficking establishments, facilitate production of fraudulent identity documents, or overlook

irregular labor recruiters."
Former Bamban, Tarlac mayor Alice
Guo was recently found guilty of qualified human trafficking and sentenced to reclusion perpetua by Pasig City Regional Trial Court Branch 167 in a case tied to the illegal operations of a Philippine offshore gaming operation (POGO) hub in her

It stemmed from last year's police raid on the Zun Yuan Technology compound, which operated on a property through leased Guo's company.

Expanded Anti-The Persons Trafficking in Act penalizes individuals who own or manage establishments used trafficking and facilitate related crimes.

The decision came out on the same day that the 11th Manila International Dialogue on Human Trafficking (MID) was being held in Makati City last November 20, 2025.

Bringing together government agencies, civil society, international partners, and the private sector, the MID has fostered meaningful dialogue and collective action to address emerging trafficking trends, strengthen policies, and promote victimcentered solutions.

at KALAM, there has been no formal notification to the Capitol regarding the new fee. The existing 40-30-30 division of sand among barangays, towns/cities, and provinces still remains, with the province collecting a ₱250 administrative fee, ₱150 sand tax, and ₱30 weighing scale fee per load.

The Porac Quarry Association said it wants to take its grievances to the proper process while

the temporary work stoppage continues, which could last up to two weeks. Engr. Dungca urged the group to escalate their concerns to the Provincial Council to find a just and beneficial

It is estimated that more than ₱40 million in provincial revenue, earmarked for health programs and services by Governor Lilia "Nanay" Pineda and Vice Governor Dennis "Delta" Pineda, will be delayed. The sand from Porac is among the best in Southeast Asia, and according to data from the Office of the Provincial Treasurer, the province's quarry revenues have exceeded ₱5 billion from 2019 to 2025. The Capitol is ready and awaits the official explanation of the LGU Porac so that the talks can continue smoothly and the issue can be resolved immediately.

At the minimum, the TPP shall contain the following: total lot and project floor area of the project; layout of planting areas; number of trees to be planted (i.e., at least one tree for every 500 sq. m. of lot area for commercial or industrial buildings, and at least one tree for every 250 sq. m. in residential buildings or developments); and species of endemic trees.

The Department of Public Works and Highways (DPWH), as administrator of the National Building Code, shall integrate the TPP requirement into building permit processes and forms while the Department of Environment and Natural Resources (DENR) shall provide the technical standards for tree selection. planting, and maintenance. The Department of Interior and Local Government (DILG) shall then oversee LGU compliance and capacity-building.

During his time as Angeles City Councilor, Lazatin also authored the landmark City Ordinance No. 456, which required business establishments to conduct a 'Greening Program' as part of the requirements for business permit application.

As Angeles City Mayor, Lazatin led the massive reforestation of the Sapangbato Watershed, in

BCDA secures ₱5.1-B investment for New Clark City Golf Estate

NEW CLARK CITY — The Bases Conversion and Development Authority (BCDA) has finalized a ₱5.1-billion investment deal with Korea Real Estate Investment & Trust (KOREIT) Asset Management and Sky Blue New Clark City Golf & Resort Corp. for a landmark golf and villa estate in New Clark City-an upcoming development expected to create 1,200 jobs and strengthen the Philippines' sports and tourism infrastructure.

KOREIT, through subsidiaries Eagle-K GC Corp. and Eagle-K RV Corp., will lead the full development and management of the 150-hectare estate. The project includes a 77-hectare 18hole championship golf course and clubhouse, a 52-hectare 9-hole extension with support facilities, and dedicated areas for residential villas and amenities. Commercial operations of the golf course are targeted for the first quarter of 2026.

BCDA President and CEO Engr. Joshua M.

Bingcang said the partnership reflects the growing confidence of international institutional investors in New Clark City's long-term vision. He noted that KOREIT's entry boosts BCDA's investment pipeline and supports plans to develop competitive and sustainable growth centers.

The ₱5.1-billion project is expected to stimulate economic activity in Tarlac and neighboring provinces by driving tourism, generating jobs, and supporting local businesses. It is also envisioned to attract both local and foreign visitors, further positioning New Clark City as a rising sports, leisure, and lifestyle destination.

Engr. Bingcang emphasized that beyond infrastructure, the development will bring new opportunities for communities and contribute to regional progress. The project adds to New Clark City's expanding lineup of public and private investments in sports, tourism, and real estate.
